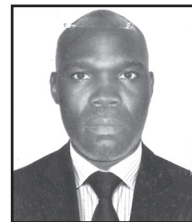

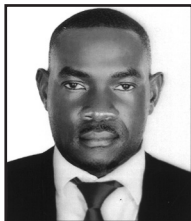

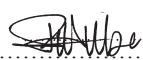
In accordance with the provisions of the local Governments (Rating) Act, 2005, notice is hereby given to the general public that the Draft Valuation List for Katabi Town Council area has been completed. A Copy of the valuation list is available for inspection at Katabi Town Council offices and all the Local council one (1) offices of Katabi Town Council for a period of 30 days from the date of publication of this notice.

Any person may take copy/copies of extract(s) from the Draft Valuation List upon payment of the relevant fees.

Any person who is aggrieved by:

1. The inclusion of any property in the Draft Valuation List; or
2. Any value ascribed in the Draft Valuation List to a property or by any other statement made or omitted to be made in the Draft Valuation List with respect to any property; or
3. In case of a building or portion of a building occupied in parts, by the valuation in the Draft Valuation list of that building or portion of a building as a single property, may, at any time before the expiration of thirty (30) days from the date of publication of this notice, serve Katabi Town Council a notice of objection to the Draft Valuation list so far as it relates to that property.

N.B. A person shall not be entitled to be heard by the valuation court unless he/she had lodged a notice of objection within the stipulated period.
