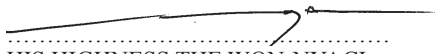

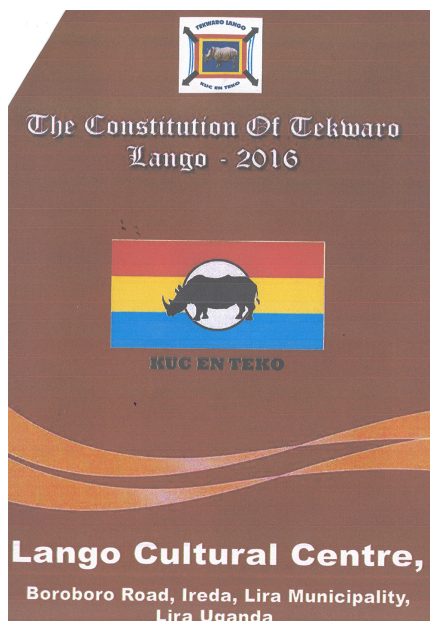

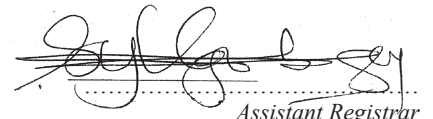
ORDER

This application is coming for final disposal this 12th day of April 2018 before Her LORDSHIP LADY JUSTICE DR. WINIFRED N. NABISINDE, the Resident Judge of the High Court at Lira, in the presence of both parties and in the absence of both counsels it is hereby ordered as:

1. That the current application, the entire head suit and out of which it arises and the applications arising therefrom and the orders previously granted by this court are found to be premature and as such can only be taken as abuse of court process and not to in interest of the people who filed them in the first place.

2. The current application, the entire head suit out of which it arises and the application arising from thereon are all accordingly dismissed.
3. The injunctive orders earlier granted by the court in Miscellaneous Application Number 30 of 2017 are also vacated and no longer have any effect on the Respondent Eng. Dr. Michael Odongo Okune.
4. The applicants/plaintiffs will however be free to bring a fresh suit in future if they have concluded any negotiations they intend to engage in with the respondent/defendant and any other interested person who subscribes to Lango culture if he feels so inclined within the paradigm of the Lango Cultural Institutions' Constitution of 2016.
5. The costs are awarded to the respondent.
