**POLICY DIRECTION RELATING TO THE 50MW  
ELECTROMAXX UGANDA LIMITED THERMAL POWER  
PLANT AT TORORO UNDER A BUILD, OWN, OPERATE  
AND TRANSFER ARRANGEMENT**  
(Under section 17 of the Electricity Act, Cap. 145)

This Policy Direction is given to the Electricity Regulatory Authority under section 17 of the Electricity Act, Cap. 145, this 3<sup>rd</sup> day of October, 2023.

## PREAMBLE

- WHEREAS** the Government of Uganda (the “Government”) in the National Energy Policy for Uganda published in 2023 set out Government’s Policy aspirations to meet the energy needs of Uganda’s population for social and economic development with the National Energy Policy spelling out the Government’s commitment to have a diversified energy generation mix that ensures the energy security of the country amidst the challenges of climate change and hydrological risk experienced by hydropower plant generation. In implementing the Energy Policy, the Government has integrated thermal power plants on the National Grid to ensure security of energy supply.
- WHEREAS** the Government in the Renewable Energy Policy for Uganda 2007 set out the Government’s policy objective to make modern renewable energy a sustainable part of the national energy consumption, there is need to ensure a diversified energy generation mix for energy security.
- NOTING THAT** Electromaxx Uganda Limited is currently Licensed by the Electricity Regulatory Authority to operate a 50MW Thermal Power Plant in Tororo, the Government intends to enter into an Implementation Agreement for 50 MW Thermal Power Plant at Tororo under a Build, Own, Operate and Transfer (BOOT) arrangement. Under this intended Implementation Agreement, Electromaxx Uganda Limited shall prudently operate and maintain the Thermal Power Plant for a period of five (5) years following the Commercial Operations Date at a declared capacity charge of USD cents 3 per KW per hour payable directly by Government through Uganda Electricity Transmission Company Limited. At the end of the five (5) years, Electromaxx Uganda Limited shall transfer the 50MW Thermal Power Plant, in a good operating condition to Government or its nominee at USD 1.

## POLICY DIRECTION

- NOW THEREFORE**, the following Policy Direction is given to the Electricity Regulatory Authority to;
  - Modify the Generation and Sale of Electricity Licence issued to Electromaxx Uganda Limited to provide for declared capacity charge of USD cents 3 per KW per hour, for 50MW Thermal Power Plant in Tororo, payable directly by Government through Uganda Electricity Transmission Company Limited.
  - Modify the Generation and Sale of Electricity Licence issued to Electromaxx Uganda Limited to align the Term of the Licence with the Term of the Implementation Agreement;
  - Modify the Generation and Sale of Electricity Licence issued to Electromaxx Uganda Limited to provide for Electromaxx Uganda Limited obligation to; Build, Own, Operate and Transfer a 50MW Thermal Power Plant at Tororo to Government or its nominee at the end of the Licence Term;
  - Modify the Generation and Sale of Electricity Licence issued to Electromaxx Uganda Limited to provide for recovery of reasonable, justified, and prudent energy payment cost based on dispatch from Power plant;
  - Ensure that the Power Purchase Agreement between Electromaxx Uganda Limited and the Uganda Electricity Transmission Company Limited in respect to the 50MW Thermal Power Plant at Tororo is aligned to the above.
