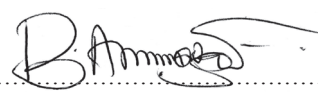

The above subject matter refers.

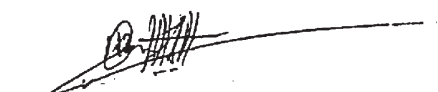
