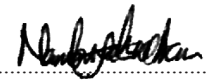
**NOTICE OF COMPLETION OF DRAFT VALUATION

In accordance with the provisions of the **Local Governments (Rating) Act 2005**, notice is hereby given to the general public that the draft **Valuation list 2024 for Kalangala Town Council** has been completed.

1. A copy of the valuation list is available for inspection at Kalangala Town Council Headquarters and at all the respective LCI offices
2. Inspection has been granted for a period of 30 days from the date of publication of this notice.
3. Any person may take copy/copies of extract(s) from the draft valuation list upon payment of the relevant fees.
4. Any person who is aggrieved;
 - a. By the inclusion of any rateable property in the draft valuation list
 - b. By any value ascribed in the draft valuation list to a rateable property or by any other statement made or omitted to be made in the draft valuation list with respect to a rateable property or,
 - c. In the case of the building or portion of a building occupied in parts, by the valuation in the draft valuation list of that building or portion of a building as a single rateable property, may at any time before the expiration of 30 days from the date of publication of a notice in accordance with section 13, fill form RF2 prescribed in the rating regulations (11), serve Kalangala Town Council a notice of objection to the draft valuation list so far as it relates to the rateable property

Important; A person shall not be entitled to be heard by the valuation court unless he/she had lodged a notice of objection within a specified period.
