POLICY DIRECTION WITH RESPECT TO THE DEVELOPMENT OF SOLAR POWER PLANTS WITH INTEGRATION OF BATTERY ENERGY STORAGE SYSTEMS ACROSS UGANDA BY ENERGY AMERICA

(Under section 16 of the Electricity Act, Cap 157)

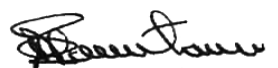
This Policy Direction is given to the Electricity Regulatory Authority under section 16 of the Electricity Act, Cap. 157 this **28th** of **July, 2025**.

PREAMBLE

- WHEREAS** the government of Uganda (the "Government") in the National Energy Policy for Uganda published in 2023 set out the Government's policy aspirations to meet the energy needs of Uganda's population for social and economic development in an environmentally sustainable manner.
- WHEREAS** in achieving the aforementioned objective, the government has deployed the strategy of disseminating renewable energy technologies to increase their positive impact on Uganda's energy balance and environmental stewardship.
- WHEREAS** the National Energy Policy 2023 aims to achieve an electricity generation capacity of 52, 481 MW by 2040.
- WHEREAS** the Renewable Energy Policy for Uganda published in 2007 set out the Government's policy objective to make modern renewable energy a substantial part of the national energy consumption and to increase the use of modern renewable energy.
- WHEREAS** the Government has undertaken to pursue the principal policy objective of improving power connectivity as provided for in the Fourth National Development Plan and the National Resistance Movement Manifesto 2021 -2026.
- NOTING THAT** Energy America intends to establish a 100 MW solar PV plant integrated with 250 MWh of battery storage at Kapeeka Sub-County, Nakaseke District as the first phase of a 10- phase roadmap leading up to 1 GW.

POLICY DIRECTION

- NOW THEREFORE**, the following Policy Direction is given to the Electricity Regulatory Authority to observe and implement:
 - Energy America shall finance, construct, operate and maintain a 100MWp ground-mount solar PV power plant with 250MWh battery storage at Kapeeka Sub-County, Nakaseke District at a tariff to be determined by Electricity Regulatory Authority upon submission of a justifiable full feasibility study to be conducted by Energy America.
 - The Power Purchase Agreement conditions shall be negotiated between Energy America and Uganda Electricity Transmission Company Limited.
