APPOINTMENT OF DATES FOR THE NOMINATION OF CANDIDATES AND BY-ELECTION OF MEMBERS OF THE EAST AFRICAN LEGISLATIVE ASSEMBLY

NOTICE IS HEREBY GIVEN as follows;

In accordance with sections 8 and 9 of the East African Legislative Assembly Elections Act, 2012, the Rt. Hon. Speaker of the East African Legislative Assembly has notified the Rt. Hon. Speaker of the Parliament of Uganda that two vacancies have occurred in the Assembly following the election of Hon. Dennis Namara (National Resistance Movement) and Hon. James Kakooza (National Resistance Movement) to the Parliament of Republic of Uganda. Consequently, the Parliament of Uganda will conduct a by-election in accordance with the roadmap here below:

NOMINATION OF CANDIDATES

The nomination of candidates for election shall be conducted in accordance with the Rules of Procedure for the Election of Members of the East African Legislative Assembly contained under Appendix C of the Rules of Procedure of the Parliament of Uganda.

I here below reproduce the relevant Rules for your information and attention:

“4. Nomination of candidates under party ticket

- (1) A political party or organisation represented in Parliament may nominate candidates for election to the Assembly in the format prescribed in Schedule 1 to this Appendix.
- (2) The nomination of candidates under sub rule (1) shall represent as much as it is feasible, gender and other special interest groups.
- (3) A political party or organisation nominating a candidate under sub rule (1) shall tender the nomination in writing to the Clerk indicating the following-
 - (a) a statement under oath specifying the name, educational qualifications, address and occupation of the candidate in the format prescribed in Schedule 1 to this Appendix; and
 - (b) a statement under oath in the format prescribed in Schedule 3 to this Appendix by the candidate stating that the candidate-
 - (i) is a citizen of Uganda;

- (ii) qualifies to be elected a Member of Parliament;
- (iii) is not a Member of Parliament;
- (iv) is not holding office as a Minister;
- (v) is not an officer in the service of the East African Community; and
- (vi) has proven experience or interest in consolidating and furthering the aims and the objectives of the East African Community.

- (4) The Secretary General of a political party or organisation, or a person authorised by the Secretary General of a political party or organisation nominating a candidate under this rule shall endorse and seal the nomination form of the candidate.

6. Signatures supporting nominations

- (1) All nomination forms shall include the names, signatures and constituency of not less than five Members of Parliament supporting the nomination of the candidate.
- (2) A Member of Parliament shall not nominate more than two candidates for this by-election to the Assembly.”

NOMINATION DATES

As mandated by Rule 3 of Appendix C of the Rules of Procedure of the Parliament of Uganda, I have appointed the following dates during which the nomination of candidates for by-election as Members to the 5th East African Legislative Assembly shall take place:

- Monday, 30 March 2026
- Tuesday, 31 March 2026

The nominations shall be conducted from **9.00 a.m. to 5.00 p.m. in the Conference Hall** at Parliament House.

NOMINATION FORMS

Intending candidates may pick the Nomination Forms from the Office of the Clerk to Parliament with effect from **Wednesday, 25 March 2026**.

PAYMENT OF NOMINATION FEE

In accordance with Rule 7 of Appendix C of the Rules of Procedure of the Parliament of Uganda, every candidate shall pay a nomination fee of **UGX 3,000,000/=**.

The Payment method is as follows:

Prospective candidates shall pay the nomination fees in cash to Mr. Justus Mugisa (Tel. No. 0772400136) seated at Parliament House, Room 212, Second Floor, South Wing and produce evidence of payment at nomination venue.

CAMPAIGN AND VOTING DAY

Campaigns and voting for all candidates duly verified and approved by Parliament shall be conducted in Parliament on **Wednesday, 15 April 2026**.
