**POLICY DIRECTION WITH RESPECT TO THE
DEVELOPMENT OF THE SOLAR PHOTOVOLTAIC POWER
PLANT BY SINEW LTD IN TORORO DISTRICT.**

(Under Section 17 of the Electricity Act, Cap. 145)

This Policy Direction is given to the Electricity Regulatory Authority (ERA) under section 17 of the Electricity Act, Cap. 145, this 27th day of March, 2026.

PREAMBLE

- WHEREAS** the government of Uganda (the "Government") in the National Energy Policy 2023, reaffirmed its aspiration to meet the energy needs of Uganda's population for social and economic development in an environmentally sustainable manner;
- WHEREAS** the government has adopted the strategy of scaling up renewable energy technologies as a key pillar in diversifying Uganda's energy mix and reducing carbon intensity in line with Uganda's Vision 2040, National Development Plan IV and NRM Manifesto 2021-2026;
- WHEREAS** the National Energy Policy 2023 envisions the attainment of a robust generation capacity anchored on renewable energy to drive industrialization, e-mobility and productive use of energy;
- WHEREAS** the Renewable Energy Policy 2007 for Uganda set out the Government's policy objective to make modern renewable energy a substantial part of the national energy consumption and this has been reaffirmed under the Energy Policy 2023 with targets for expanding Solar PV and battery energy storage;
- WHEREAS** the Government is committed to strengthening Uganda's energy transition by supporting Independent Power Producers (IPPs) that demonstrate capacity, technical compliance, and financial readiness to invest in Solar PV and grid-supportive infrastructure;
- NOTING THAT** Sinew Ltd (hereinafter referred to as "the Developer") has successfully developed and operationalized renewable energy facilities in Uganda, and has now undertaken preliminary pre-feasibility studies for the establishment of a 35 MWAC with 11MW battery storage solar PV power plant in Tororo District;

POLICY DIRECTION

NOW THEREFORE, pursuant to section 17 of the Electricity Act, Cap. 145 the following directives are hereby issued to the Electricity Regulatory Authority (ERA):

- Licensing & Tariff Setting: ERA shall, upon submission of a comprehensive and justifiable full feasibility study by the Developer, process and determine a cost-effective tariff for the proposed solar PV power plant in Tororo District, ensuring alignment with the RE-FIT VI framework and Uganda's long-term, least cost power development strategy.
- The Power Purchase Agreement (PPA); The PPA conditions shall be negotiated between the Developer and Uganda Electricity Transmission Company Limited (UETCL), in accordance with ERA's standard guidelines ensuring bankability for the investor while safeguarding consumer affordability and grid stability.
- Grid Integration & Phased Expansion: ERA shall work with UETCL and the Developer to ensure that the project's design, interconnection studies and phased expansion plan are aligned with the Electricity Grid Code and Uganda's Transmission Development Plan, including potential integration of Battery Energy Storage Systems (BESS) to enhance grid reliability.
- Local Content & Sustainability: ERA shall ensure that the Developer integrates local content participation, community engagement and environmental and social safeguards into the project in line with Uganda's local content regulations, the National Environment Act, and global Environmental, Social and Governance (ESG) best practices.
