Both parties will have the opportunity to present their cases in a hearing before the Registrar issues a final decision.

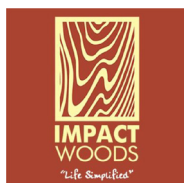

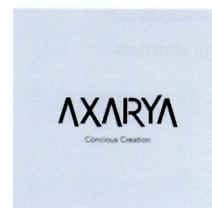
