(57) **Abstract:**

The "Life-Saving Jacket" is an eco-friendly flotation device made from recycled plastic bottles and reinforced mosquito-net textile. The invention relates to an eco-friendly life-saving jacket constructed primarily from recycled materials. The jacket comprises an inner buoyancy assembly made from reinforced mosquito-net textile containing a plurality of recycled plastic soda bottles arranged in compartments to provide flotation. The buoyancy assembly is tailored to fit the human torso and enclosed within an outer vest-like fabric structure equipped with adjustable fastening mechanisms
