**(57) Abstract:**

Abstract: The present technology relates to a fluid control device, typically a water control device, comprising an electric driven valve and and/or a flowmeter. The electric drive valve according to one aspect of the present technology is configured so that once the valve is driven to the open or closed state by an electric signal or by other driving forces, the valve can be maintained in that state by using magnetic force, thereby not requiring the electrical signal being continuously provided. The flowmeter according to one aspect of the present technology is composed of an impeller that includes a material that is not magnetized.

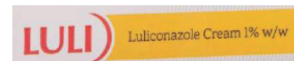
